The year has started very busily – Suomi-Seura celebrates 90 years, Expatriate Parliament 20 years in addition to Finland’s centennial of independence. Hopefully you will answer the Finnish Expatriate of the Year and “Lippu korkealla” surveys. You have until January 27 to submit. More later in the newsletter.

### Finnish Expatriate Parliament anniversary Congress approaches

The USP/FEP 20<sup>th</sup> anniversary year complements its secretariat’s 90<sup>th</sup> anniversary. After the inaugural USP/FEP meeting on 4-5.8.1997, seven congresses have been held. The ninth general meeting will be held on 16-17.6.2017 in the Festival Hall, University of Helsinki. In the spirit of the celebration’s theme, “Together”, we call on all Finnish Expatriate organizations, which have ratified the USP constitution, to gather in Helsinki. Active member organizations can send both delegates and observers. Non-member organizations have until 16.3.2017 to join by ratifying the USP constitution. Registered member organizations must inform of their delegates by 4.5.2017.

The preliminary program on Thursday, 15.6 includes an opening church service in “Vanhakirkko”, Senior and Suomi-koulu seminars. Some regions will elect their Deputy Speakers and alternates also on this day. The City of Helsinki will host the Congress participants on Friday evening.

### Youth Travel Subsidy to attend the USP Congress

Youth delegates (30 years of age or younger) attending the Congress will be given an extra travel subsidy. Those crossing an ocean will receive 500 euros, Scandinavian, Baltic and Russian delegates will receive 100 euros, and the remaining Europeans will be given 300 euros.

Subsidy applications will be accepted until 28.2.2017. The outcomes will be announced by the end of March. The condition of funding is that the recipient will represent a member organization. ## **New Board of Education started up at the beginning of the year**

CIMO and the Board of Education joined to form the new Board of Education. The office has as its mandate to direct education, early childhood education, life long learning and advance international learning. The General Manager is Olli-Pekka Heinonen. All 370 staff will move to the new board.

The board has an annual budget of 223 million euros. About 58% will be distributed to clients via grants, subsidies and project funding. About 32% of that amount is directed to international initiatives. The budget for educational institutions operating under the Board of Education in Finland is 50 million euros. Funding is received mostly from the Ministry of Education and Culture, but the European Commission is also a major financial contributor.

## **Finnish Citizenship to 749 persons by notification in 2016**

A total of 788 notifications were received. Of those, 772 proceeded to a decision stage, of which 749 were positive and 23 negative. Former Finnish citizens can receive citizenship by notification, as well as their children under 18 years of age, when included in the application.

A total of 11,918 persons applied for Finnish citizenship. A positive decision was given to 9,644 applicants. Most applicants were Russians, Somalis, Iraqis, Estonians and Afgans.

## **YLE Suomi Finland 100 channel can be viewed**

Yle Arena has inaugurated a Suomi Finland 100 channel. It is a net channel designed to tell the story of Finland with the aid of archived materials. How was Finland built, how have the vistas, culture, customs and citizens changed during these decades? The archival materials will take you to the nostalgic centennial of Finland.

Suomi Finland 100 is visible worldwide with a few exceptions due to rights issues. There will be twenty different themes, which show the history of Finland, its literature, culture and sports. A magnificent program on the Finnish nature, filmed over three years, will be shown later. Expatriate Finns can offer videos of their own celebrations. YLE has also produced programs about expatriate Finns. YLE will film all major events in Finland, starting with the New Year's Eve coverage of the beginning of the celebratory year. <http://arena.yle.fi/1-3857930>
